**EUN CHONG (EJ) THORSEN APPOINTED TO
COMMISSION ON STATEWIDE DISCIPLINE**

Associate **Eun Chong (EJ) Thorsen**, a resident of **Forest Hills** and an associate in the Litigation Practice at **Lake Success** law firm **Vishnick McGovern Milizio LLP**, has been appointed to serve on the New York State Unified Court System's new Commission on Statewide Discipline, chaired by Chief Administrative Judge **A. Gail Prudenti**. The Commission will conduct a comprehensive review of the attorney disciplinary system throughout the state and issue recommendations on how to reshape attorney discipline in New York to ensure fairness, efficiency and effectiveness.

In her invitation to serve, **Matthew G. Kiernan**, Special Counsel to the Chief Administrative Judge, cited Ms. Thorsen as "a distinguished leader in New York's legal community" who "Chief Judge Lippman and Chief Administrative Judge A. A recipient of a *Queens Courier* Rising Star award, Ms. Thorsen was honored as one of the borough's top young professionals in 2014.

Ms. Thorsen received her Juris Doctor degree from St. John's School of Law and her Bachelor's degree from Boston College. She previously served as a judicial intern with the Honorable Joseph F. Bianco of the Eastern District of New York and the Honorable Patricia P. Satterfield of the Queens County Supreme Court.
